

## Realm Royale Tournament Rules

### REALM ROYALE SUMMER 2018 INVITATIONAL TOURNAMENTS SUPPLEMENTAL RULES

Last updated July 17, 2018

#### 1. TERMS OF AGREEMENT

PLEASE READ THESE SUPPLEMENTAL RULES CAREFULLY BEFORE ACCEPTING THE FOLLOWING TERMS AND CONDITIONS. PARTICIPATION IN THE REALM ROYALE SUMMER 2018 INVITATIONAL TOURNAMENTS (SOLELY FOR THE PURPOSES OF THESE SUPPLEMENTAL RULES, EACH, A "TOURNAMENT") IS CONDITIONAL ON YOUR AGREEMENT AND COMPLIANCE WITH ALL THE TERMS AND CONDITIONS PROVIDED IN THESE SUPPLEMENTAL RULES IN ADDITION TO THE GENERAL RULES.

These Realm Royale Summer 2018 Invitational Tournaments Supplemental Rules supplement and amend the terms and conditions of the Realm Royale Tournament Rules (for the purposes of these Supplemental Rules, the "General Rules") between you as a participant ("You" or "Your") and Hi-Rez Productions, Inc. d/b/a Skillshot Media ("Tournament Operator"). These Supplemental Rules are to be read and construed with the General Rules as a single contractual agreement. Capitalized words used in these Supplemental Rules have the same meaning assigned to them in the General Rules unless otherwise expressly indicated in these Supplemental Rules.

These Supplemental Rules are subject to change from time to time, in Tournament Operator's sole discretion.

In the event of any inconsistency between these Supplemental Rules and the General Rules, the Supplemental Rules shall control unless otherwise expressly indicated.

#### 2. ADDITIONAL ELIGIBILITY REQUIREMENTS

In addition to the eligibility requirements set forth in the General Rules, Players must also meet the following criteria to be eligible for the Tournament:

- a. Player must receive an invitation from Tournament Operator for the applicable Tournament; and
- b. Player must register for an open participant slot for the applicable Tournament with the designated form by the corresponding deadline (the "Deadline"). Registration for a Tournament will close once all participant slots are filled.

(such Player is hereafter defined as "Invitee");

#### OR

- c. If a Player was invited by another Player that was invited by Tournament Operator (i.e. is an Invitee), then Player must be listed by Invitee as Invitee's partner on such designated registration form for the applicable Tournament (such Player is defined herein as "Partner").

Subject to any instructions by Tournament Operator and the Rules, Players who have participated in previous Tournaments may be eligible to participate in subsequent Tournaments.

Players may only participate in these Tournaments in their capacity as natural persons. Organizations are not eligible to participate in these Tournaments except as Player sponsors. For the avoidance of doubt, any such Organizations will have no right to any qualifying slots, prizing, accomplishments, or otherwise with respect to a Player's performance in the Tournaments.

### **3. TOURNAMENT INFORMATION**

These Supplemental Rules apply to the Tournaments operated by Tournament Operator, beginning on the week of July 15, 2018 and taking place approximately two times each calendar week thereafter until Tournament Operator ceases to operate such Tournaments.

The scheduled date and additional details for each applicable Tournament will be set forth in e-mail communications by Tournament Operator to the Invitee (or other methods of online communications as may be designated by Tournament Operator). The first Tournament is initially scheduled to take place on or around July 18<sup>th</sup>, 2018.

Invitee is responsible for communicating or providing to Invitee's Partner any Tournament dates, details, these Rules, or any applicable forms and documents as provided to Invitee by Tournament Operator.

### **4. REGION**

The Tournaments are open to all regions for participation, provided, however, that the Teams shall participate in the Tournaments on the server region(s) designated by Tournament Operator.

### **5. REPRESENTATIVE AND ASSISTANT**

Unless Tournament Operator is otherwise notified in writing by both Invitee and Partner prior to Deadline, Invitee shall be the designated Representative of the Team and Partner shall be the designated Assistant Representative.

### **6. TOURNAMENT FORMAT AND SCORING**

The Game mode will be "Duo". Teams must consist of two Players. No alternates or coaches are permitted for these Tournaments.

Unless Teams are informed otherwise by Tournament Operator, each Tournament will consist of 10 Tournament Games, after which winning Teams will be determined based on Teams with the lowest final score. Scoring will be determined in accordance with the standard scoring method set forth in the General Rules.

### **7. TIES**

In the event of a tie, the amount of prizing awarded, if any, will be divided equally among the number of Players on such tied Teams and Tournament Operator will make such payment of prizing accordingly.

### **8. PRIZING AND ADDITIONAL PAYMENT INFORMATION**

Prizing for each of the Tournaments will be awarded as follows:

<b>1<sup>st</sup> PLACE</b>	\$ 5,000.00 U.S. Dollars
<b>2<sup>nd</sup> PLACE</b>	\$ 2,500.00 U.S. Dollars
<b>3<sup>rd</sup> PLACE</b>	\$ 1,250.00 U.S. Dollars
<b>TEAM WITH MOST ELIMINATIONS</b>	\$ 1,250.00 U.S. Dollars

All prizing payouts are subject to your compliance with these Rules. For clarity, the prizing set forth above is not per Tournament Game, but per Tournament.

Payment of a Team's earned prizing will be made to Invitee and Partner, with each such Player receiving one-half of the untaxed earned prizing. Invitee and Partner are solely responsible for any payment obligations, if any, to each other with respect to any Tournament prizing. If a Player desires to direct payment of their prizing to any other party, including to Invitee or Partner, then such Player must notify Tournament Operator in writing and execute the appropriate paperwork provided by Tournament Operator for such payment direction.,

## **9. BROADCAST**

Players may broadcast, livestream, or upload video content of their participation in the Tournaments solely to online channels owned or controlled by Player. Any such use is subject to the Hi-Rez Studios Policy for Streaming Video and Videos-On-Demand <available at <https://www.hirezstudios.com/legal/>>.

## **10. QUALIFIERS AND EVENT INVITATIONS**

Participating Teams may qualify, or receive invitations from Tournament Operator, for other future Game or Tournament Operator events. In the event a Team qualifies or receives an invitation to participate in such future events, unless otherwise expressly permitted by Tournament Operator in writing, any such qualification is conditioned on such Team remaining comprised of the same individual Players.
