



**2018 Paladins® OB64 Fanart Spray Submissions Program Official Rules**

Champions of the Realm, we've heard you loud and clear! You traumatized us with your "crappy" art, and now we want to return the favor by immortalizing the very worst as in-game Sprays.

**IMPORTANT LEGAL NOTICE!**

Please read the following program rules carefully before participating in the OB64 Fanart Spray Submissions Program (the "Submission Program"). This OB64 Fanart Spray Submissions Rules, Terms, and Conditions (the "Rules") is between you as a participant and Hi-Rez Studios, Inc. ("Hi-Rez"). By participating in the Submission Program, you confirm that you have read and agree to be bound by these Rules and represent that you satisfy all eligibility requirements for this program.

**1. ELIGIBILITY.**

a. This Program is open to residents of the following: THE UNITED STATES (EXCLUDING RESIDENTS OF NORTH DAKOTA, VERMONT, CONNECTICUT, OR MARYLAND), ARGENTINA, AUSTRALIA (EXCLUDING THE AUSTRALIAN STATES OF NEW SOUTH WALES OR THE AUSTRALIAN CAPITAL TERRITORY), AUSTRIA, BELARUS, BELGIUM, BELIZE, BOLIVIA, BULGARIA, CHILE, CANADA (EXCLUDING QUEBEC), COLOMBIA, COSTA RICA, CROATIA, DENMARK, ECUADOR, EL SALVADOR, ESTONIA, FRANCE, FINLAND, GERMANY, GREECE, GUATEMALA, HONDURAS, HONG KONG, HUNGARY, ICELAND, IRELAND, ISRAEL, ITALY, JAMAICA, JAPAN, LATVIA, LITHUANIA, LUXEMBOURG, MACAU, MALAYSIA, MEXICO, NEW ZEALAND, NICARAGUA, NORWAY, PARAGUAY, PERU, POLAND, PORTUGAL, PUERTO RICO, ROMANIA, RUSSIA, SERBIA, SINGAPORE, SLOVAKIA, SOUTH AFRICA, SOUTH KOREA, SPAIN, SWEDEN, SWITZERLAND, TAIWAN, THAILAND, THE CZECH REPUBLIC, THE NETHERLANDS, THE PEOPLE'S REPUBLIC OF CHINA, THE UKRAINE, THE UNITED KINGDOM, TURKEY, URUGUAY, OR VENEZUELA;

IF YOU MEET ALL OF THE ABOVE CRITERIA AND REGISTER FOR THE PROGRAM, YOU ARE HEREBY DEEMED AN "ENTRANT" FOR PURPOSES OF THIS AGREEMENT. IF YOU DO NOT MEET THE ABOVE CRITERIA, YOU ARE NOT ELIGIBLE TO WIN A PRIZE.

## **3. REGISTRATION.**

We will be accepting submissions (each, a "Submission") beginning on February 27, 2018, 12:00 AM EST and ending February 28, 2018, 11:59 PM EST (the "Deadline"). Submissions must be received during the active submission window to be eligible for prizing. Hi-Rez reserves the right to extend the Submission Program period, in its sole discretion, with or without notice. For purposes of this Program, a calendar day is defined as beginning at 12:00 AM, (EST) and ending at 11:59 PM (EST).

## **4. PRIZES.**

Program winners (collectively, the "Prize Winners") will be selected as follows:

Judging will occur between February 27, 2018, through and including February 28, 2018 . Hi-Rez shall, at its sole discretion, appoint a panel of judges to select up to 10 Submissions based on originality, design, and presentation which will be posted on a website of Hi-Rez's choosing on February 28, 2018. Users will be allowed to vote for their favorite Submission from the time such Submissions are announced through March 1, 2018. The 3 Prize Winners will be announced on the Paladins patch notes show (available for viewing at <https://www.twitch.tv/paladinsgame/>) on March 1, 2018.

The decision of Hi-Rez is final. To claim the applicable reward, Prize Winners should follow the instructions provided to them by Hi-Rez.

a. ALL FEDERAL, STATE, AND LOCAL TAXES ASSOCIATED WITH THE RECEIPT OR USE OF ANY PRIZES ARE THE SOLE RESPONSIBILITY OF THE WINNER.

b. All prizes will be awarded. Prize Winners may need to execute an affidavit of eligibility before they can receive their prize. Prizes will be awarded provided a sufficient number of eligible entries are received. Prizes returned as undeliverable or otherwise not claimed within fifteen (15) calendar days after delivery of notification will be forfeited and may be awarded to an alternate winner. ## **5. HOW TO ENTER; SUBMISSION RESTRICTIONS.**

### **I. Submission Ownership and Other Rights**

#### **a. Submission Ownership.**

- i. All Submissions and other materials ("Submission Entries") submitted by you become the property of Hi-Rez upon submission. You acknowledge that Hi-Rez owns all rights to use, modify, and make derivative works of any Submission Entries without notice or compensation to you.
- ii. You agree to assist and cooperate with Hi-Rez in all respects, at Hi-Rez's request and expense, and shall execute documents and take further actions reasonably requested by Hi-Rez to enable Hi-Rez to acquire, transfer, maintain, perfect, and enforce its Intellectual Property Rights as well as the license grants from You to Hi-Rez set forth herein. You hereby appoint the officers of Hi-Rez as Your attorney-in-fact to execute documents on Your behalf for this limited purpose.
- iii. You acknowledge that the Intellectual Property Rights in and to the Game are exclusive to Hi-Rez, including but not limited to the right to use, reproduce, sell, distribute, broadcast, publicly display, and make derivative works thereof. The term "Intellectual Property Rights" means any and all tangible and intangible and now known or hereafter existing (i) rights associated with works of authorship throughout the world, including, without limitation, copyrights, moral rights, and mask-works; (ii) trademarks, service marks, trade names, trade dress, symbols, logos, designs, other source identifiers, and similar rights; (iii) trade secret rights and rights in and to confidential or proprietary information; (iv) patents, patent rights, patent applications, inventions, designs, algorithms and other industrial property rights; (v) all other proprietary and intellectual property rights of every kind and nature throughout the

world and however designated, (including logos, character rights, “rental” rights, moral rights, and all applications therefor, however designated), whether arising by operation of law, contract, license, or otherwise; and (vi) any and all registrations, applications, renewals, records, extensions, continuations, divisions, divisions in part, or reissues thereof (including rights in any of the foregoing), whether now or hereafter in force.

b. Moral Rights. You hereby waive any and all Moral Rights to the Submission. “Moral Rights” mean any rights to claim authorship of a work, to object to or prevent modification or destruction of a work, to withdraw from circulation or control the publication or distribution of a work, and any similar right, existing under judicial or statutory law of any country in the world, or under any treaty, regardless of whether or not such right is called or generally referred to as a “moral right”.

a. Submission Requirements. As a participant in the Program, you must comply with certain minimum restrictions set by Hi-Rez, including, without limitation, the following:

i. iii. The Submission must be authorized, which means that you must have the legal right and any and all permissions necessary to submit the Submission into the Program. By submitting the Submission, you hereby represent that you have all rights necessary to distribute the Submission through any applicable channel (e.g., the website and submission form) and to grant Hi-Rez the rights set forth herein.

iv. With the exception of any Hi-Rez intellectual property you might use, the Submission must be your original work and must not infringe the copyright, trademark, privacy, publicity, or any other intellectual property right of any person or entity.

v. The Submission must meet any and all specifications set forth by Hi-Rez in these rules and/or other instructions, including, without limitation, character, theme, format, file size, and any other specifications.

vi. With the exception of any Hi-Rez intellectual property you may use in the Submission, you represent and warrant that: (A) you are the sole and exclusive creator and owner of the Submission, and any and all rights related thereto; (B) you have the full and exclusive right, power, and authority to submit the Submission to Hi-Rez upon the terms and conditions set forth herein; (C) no rights in the Submission have previously been granted to any person or entity, or otherwise exercised or

exploited; (D) the Submission has not been submitted for any other contest(s) and it has not won any previous awards or prizes; and (E) the full use of the Submission or any part thereof will not in any way violate or infringe upon any copyright (statutory or otherwise), constitute a libel or defamation of or an invasion of the rights of privacy or publicity of, or otherwise violate or infringe upon any other personal, property, or other rights of any person, firm, corporation, or other entity or subject Hi-Rez to any costs or liability of any kind or nature whatsoever.

vii. **You may make up to 2 Submissions.** However, each Submission must be unique, and you cannot submit the same Submission more than once. Any duplicate or materially similar Submissions may be disqualified.

## **6. HI-REZ'S RIGHT TO DISQUALIFY.**

If Hi-Rez believes that the Submission does not comply with these rules or any other applicable terms and conditions, or that the Submission potentially or actually infringes upon the copyright or other rights of any third party, Hi-Rez reserves the right in its sole discretion to disqualify and remove any Submission at any time. In the event that a Prize Winner is disqualified, the prize will be forfeited and may, at Hi-Rez's sole discretion, be awarded to an alternate selected from among the remaining Entrants.

## **7. USE OF ENTRIES.**

## **8. INFORMATION COLLECTION.**

All personal information which may be collected will be treated in a manner consistent with Hi-Rez's privacy policy, which is located at <<http://legal.hirezstudios.com>>. Please review all applicable materials. By entering the Program, you hereby agree to Hi-Rez's collection and use of your personal information and acknowledge you have read and accepted these rules and Hi-Rez's privacy policy. Further, by entering the Program, you consent to Hi-Rez's use of this information to inform you of the outcome of the Program, to award you with any applicable prizing, and to associate your name and/or alias with your submission in promotional materials for the Program in the event that you are chosen to be a winner. As stated above, the contest is not open to anyone under the age of majority in your country of citizenship. In the event that Hi-Rez becomes aware that you are under the age of majority in your country of citizenship, Hi-Rez will delete, erase, or destroy any and all personally identifiable information that is obtained from your entry

form.
